Privacy Policy

DataForge Limited ("us", "we", or "our") is committed to maintaining the highest standards to safeguard personal information. This Privacy Policy outlines when we collect personal information and how we handle it. Collection, Storage, and Use of Personal Information:

Data Security Measures:

Data Retention:

Personal information provided is securely held by us. It may be shared with third-party contractors only as needed for the administration of the service or for collaboration on special projects. Your personal information will not be shared without your consent, except where required by law.

Cross-Border Data Transfers:

We operate and store data on servers located outside of New Zealand. As a result, your personal information may be transferred to, processed in, and stored in countries other than New Zealand. Statistical Information and Cookies:

To improve the Service and configure its settings, we may collect statistical information about

your visit using website 'cookies'. A cookie is a code snippet that generates a file on your computer to track the pages viewed on our Service or to support its functionality.

Google Analytics:

We utilise Google Universal Analytics to gather and analyse usage details of our Service. Collected data is stored on Google Analytics servers and is accessible to authorised staff only.

Information collected by Google Analytics includes:

- The first three parts of the IP address of the device
- Pages accessed on our site and links clicked
- Date and time of the visit
- Referring site, if any, through which the visit was initiated
- Operating system and web browser details
- Additional incidental information like screen resolution and language settings.

Microsoft:

We partner with Microsoft Clarity and Microsoft Advertising to capture how you use and interact with our website through behavioural metrics, heatmaps, and session replay to improve and market our products/services. Website usage data is captured using first and third-party cookies and other tracking technologies to determine the popularity of products/services and online activity. Additionally, we use this information for site optimisation, fraud/security purposes, and advertising.
